### **Chairman's Report 2018 – Alison Kent**

In many ways 2018 has been rather a frustrating and disappointing year. We are all still waiting for news about the outcome of Brexit.

The ongoing Agriculture Bill is slowly working its way through Parliamentary procedure with the promise from Michael Gove of “public money for public good”. This promise could ultimately mean a good outcome for improved public access and Rights of Way.

Your Committee met 4 times this year. Mounted rides were organised during the summer months, but yet again this year they were very poorly supported and two had to be cancelled due to insufficient numbers.

However, the Mounted Trec & Treasure Hunt in September proved to be very popular and 21 new members joined on the day.

### **B.H.S.**

The BHS, to whom we are affiliated, is growing in strength through increasing membership numbers which in turn means a louder voice to lobby the Government for better or improved riding facilities.

A survey carried out this summer by the BHS asking members what their main riding activity was came back with a resounding 96% citing “hacking out around the countryside” as the main reason they rode. This emphasises the importance of our national Rights of Way network, and here on Exmoor we are extremely fortunate to be within a National Park who take good care of almost 1,000 Kms of paths within its boundaries.

The BHS is encouraging all riders in England and Wales to participate in their project “Finding Lost Ways” before the cut off deadline of 1<sup>st</sup> January 2026. Lost Ways are unrecorded paths that are currently used, but which do not appear on the Definitive Map. They can only be added as a public right of way by using **historical evidence ONLY**. ### **ENPA.**

Several path diversions have been completed this year. WS&EBA are always fully consulted before a legal Path Order is made.

Kendle Farm at Exton. Wydon Farm at Minehead Without.

South Hill Farm at Withypool.

Improvements have been carried out on the following bridleways: -

Postman’s Path, Exmoor. West Anstey to Zeal Ford. White Rocks (West Anstey Ridge Road to Slade Lane)

The anomaly at Winstichen Farm near Simonsbath needs to have some historical research carried out, to try and establish whether or not the missing link of a few metres should be legally joined up

to the existing bridleway in the adjacent field.

### **General Data Protection Act 2018**

This Act came in to being in April. Even though we are a very small organisation we must still fulfil the legislation requirements of this Act.

### **Treasurer's Report**

Bank balance as on 30 September 2018 **£1,235.69**
